May 5	Fall Quarter class schedule available in ctcLink.
May 5	Fall Quarter advance registration times available on ctcLink for currently enrolled students.
May 14 – May 23	Advance Fall Quarter registration begins for currently enrolled degree or certificate seeking students.
May 26	Returning and transfer students (30+ college credits) Fall Quarter 2025 registration begins.
Jul 22 – Jul 23	New Student Orientation Fall 2025 scheduled by appointment only. Call the Admissions Office 509.574.4712 for details.
Aug 12	Deadline: All transcripts (college and high school) must be received for Fall Quarter 2025 for full or part-time transfer student admission by 3:00pm.
Aug 12	Deadline: Last day to apply and the pay Fall Quarter 2025 application fee for new, *returning, transfer and full or part-time students seeking a degree or certificate.
Aug 19	Deadline: Last day for students to complete placement testing and schedule New Student Orientation appointment in Yakima and Grandview.
Aug 25	**Tuition is due by 3:30 PM on this date. Any courses with unpaid balances will be dropped after 3:30 PM.
Aug 26 – Aug 28	New Student Orientation Fall 2025 scheduled by appointment only. Call the Admissions Office 509.574.4712 for details.
Sep 1	Labor Day Holiday Observed – College is closed.
Sep 15	**Tuition is due by 3:30 PM on this date. Any courses with unpaid balances will be dropped after 3:30 PM.
Sep 15 – Sep 19	Fall Quarter registration begins for part-time non-degree/certificate seeking students.
Sep 22	Fall Quarter 2025 classes begin.
Sep 22 – Sep 23	Students can add a class in ctcLink, no instructor signature needed.
Sep 22 – Sep 26	Refunds – 100% refund period ends on September 27th. Drops can be completed on ctcLink or by using the Add/Drop Form after September 23.
Sep 24 – Sep 26	Students can add a class with instructor email. Class adds will need to be completed using the Add/Drop Form
Sep 29 – Oct 10	Refunds – 50% refund period ends on October 11. Drops must be completed using the Add/Drop Form .
Sep 30 – Oct 4	Students can drop a class in this period and the class does not appear on transcript. All drops after September 25 must be completed on an Add/Drop Form and submitted to Registration.
Oct 2	**Tuition is due by 3:30 PM on this date. Any courses with unpaid balances will be dropped after 3:30 PM.
Oct 3	Census Date- Last day to adjust enrollment level for Financial Aid
Oct 6 – Nov 7	Students can withdraw from a class in this period and the grade appears as a “W” on transcript. Drops must be completed on an Add/Drop Form .
Oct 20	Assessment Workday – No day classes.
Oct 24	Incomplete grades for Summer Quarter 2025 and Spring Quarter 2025 due in Registration & Records Office.
Nov 4	Advising Day – No daytime classes are held on advising day. Evening classes that begin after 6:30pm are held at their normal times. All Bachelor of Applied Science classes follow their regular schedule.
Nov 7	Deadline: Last day to withdraw from Fall Quarter. Drops must be completed using the Add/Drop Form .
Nov 11	Veterans Day Holiday Observed – College is closed.
Nov 17	Spring Quarter 2026 graduation application deadline.
Nov 26	Faculty Non-contract Day – No classes. Limited college services available.
Nov 27 – Nov 28	Thanksgiving Holiday & Native American Heritage Day Observed – College is closed.
Dec 5	Last day of classes for Fall Quarter.
Dec 8 – Dec 10	Fall Quarter Final Exams administered.
