Mar 5	Returning and transfer student (30+ college credits) Spring Quarter 2025 registration begins.
Mar 13	Deadline: Last day for students to complete placement (testing) and schedule New Student Orientation appointment in Yakima and Grandview .

Apr 1 – Apr 7	Refunds- 100% refund period ends April 7. Drops can be completed in ctclink or by using the Add/Drop Form . (after April 2)
Apr 1 – Apr 14	Students can drop a class in this period and the class does not appear on transcript. All drops after Apr 2. must be done using the Add/Drop Form
Apr 3- Apr 4	Students can add a class with instructor permission email. Class adds will need to be completed using Add/Drop Form .
Apr 8 – Apr 21	Refunds- 50% refund period ends on April 21. Drops must be completed by using the Add/Drop Form
Apr 14	Census Date- last day to adjust enrollment level for Financial Aid
Apr 14	**Tuition is due by 3:30 PM on this date. Any courses with unpaid balances will be dropped after 3:30 PM.
Apr 15 – May 16	Students can withdraw from a class in this period and the grade appears as a "W" on transcript. Drops must be completed by using the Add/Drop Form .
Apr 18	Deadline: Last day to submit Winter/Spring/Summer 2025 degree/certificate applications to be included in the June commencement program.
Apr 21	Faculty deadline for ordering custom caps and gowns.

May 6	Advising Day – No day-time classes are held on advising day. Evening classes that begin after 6:30pm are held at their normal times. All Bachelor of Applied Science classes follow their regular schedule.
