| June 20 | College is closed on Fridays through August. |

| May 14 – June 23 | Summer Quarter 2025 online registration begins. Open for all students. |
| May 12 | *Summer Quarter 2025 Financial Aid applications become available on-line www.yvcc.edu/financial-aid/forms/. |
| May 22 | Deadline : Last day to apply and pay admission fee for Summer Quarter 2025 for new, ** returning, transfer and full or part-time students seeking a degree or certificate. |
| May 22 | Deadline : All transcripts (college and high school) must be received for Summer Quarter 2025 for full or part-time transfer student admission. |
| May 29 | Deadline : Last day for students to complete placement (testing) and schedule New Student Orientation appointment in Yakima . |
| June 11 | ***Tuition is due by 3:30 PM on this date. Any courses with unpaid balances will be dropped after 3:30 PM. |
| June 12 | New Student Orientation Summer/Early Fall 2025: By appointment only. Call the Admissions Office 509.574.4712 for details. |

| June 23 – June 24 | Students can add a class without instructor signature via ctcLink. |

| June 23 – June 26 | Refunds- 100% refund period ends on June 26 th . Drops can be completed through <u>ctcLink</u> or by using the on-line <u>Add/Drop Form.</u> |
| June 23 – July 2 | Students can drop a class in this period and the class does not appear on transcript. All drops after June 26 th must be done using the on-line Add/Drop Form. |
| June 30 – July 2 | Refunds- 50% refund period ends on July 2nd. Drops must be completed on an Add/Drop Form and submitted to Registration. Drops must be completed by using the on-line Add/Drop Form . |
| July 1 | ***Tuition is due by 3:30 PM on this date. Any courses with unpaid balances will be dropped after 3:30 PM. |
| July 1 | Any classes added after this date will not be dropped for nonpayment. Students are responsible for all charges and nonpayment will result in tuition blocks and possibility of being sent to collections. |
| July 2 | Census Date-Last day to adjust enrollment level for Financial Aid. |
| July 4 | Independence Day - Holiday, College Closed |
| July 3 – July 24 | Students can withdraw from a class in this period and the grade appears as a "W" on transcript. Drops must be completed by using the on-line Add/Drop Form. |

| July 24 | Last day to withdraw from classes for Summer Quarter. |
| Aug 7 | Last day of Summer Quarter. |

**Returning students are students who have not attended YVC for the last four or more quarters (not including summer).

*** If you are receiving financial aid assistance you are responsible for verifying that your funds are ready to apply to tuition and fees. Currently enrolled students may be dropped from all classes if your tuition is not paid by this date.

****Summer school attendance does not insure admittance to Fall Quarter. For Fall Quarter admittance, you must complete the admission process by published deadlines.
