**B.** Executive Session -Chair Baldoz read the announcement that the meeting would be moved into Executive session for 10 minutes to discuss evaluating the qualifications of a candidate for appointment to elective office. Bertha Ortega presented to the Board of Trustees the electing of naming Dr. Teresa Rich as the Interim President of Yakima Valley College for up to a two-year term while the college works on hiring a permanent replacement for Dr. Kaminski. The Human Resources Director will draft an interim contract for this candidate and if will be presented to the board for approval at the next board meeting.
