Chair Whitefoot called the regular meeting of the Board of Trustees to order at 4:30 p.m. Chair Patricia Whitefoot, Trustee Robert Ozuna were present. Vice Chair Rosalinda Mendoza initially joined the meeting by phone, she arrived in person at 5:03 p.m. Trustee Baldoz joined the meeting at 4:36 p.m. Trustee Sara Cate was absent (excused). Chair Whitefoot left the meeting at 5:15 p.m. after VP Ybarra's report (excused).

Introduction of Guests and New Employees. Mr. Mark Rogstad, Director of Human Resource Services, introduced Dr. Marcia Somer, Dean of Grandview Campus.

- B. **Proposed Changes to the Agenda.** There were no changes to the agenda.
- C. **Approval of Minutes**. Trustee Ozuna moved that the minutes of the Special and Regular Meetings of May 18, 2017, be approved as submitted. The motion was seconded by Trustee Mendoza and passed unanimously.

D. Action Items

1) Approval to offer Bachelor of Applied Science Degree in Teacher Education.

Mr. Tomás Ybarra stated that RCW 28B.50.810 authorizes the Washington State Community and Technical Colleges to offer applied baccalaureate degrees, consistent with their college mission and with the approval of their respective Boards of Trustees. The Yakima Valley College mission calls upon the college to offer professional and technical education that responds to the needs of our diverse communities. The college finds clear evidence of an unmet need for applied bachelors' degrees within the YVC service district and across the greater Eastern Washington region. Evidence indicates that annually the number of newly certified teachers accepting teaching positions in Yakima County is insufficient to meet demand. This includes teachers with endorsements in K-8 Elementary Education, P-3 Early childhood education, and English language Learners. Additionally, district superintendents expressed the need to diversify their teacher ranks to include more teachers with abilities to connect with culturally diverse students, including Latino students. The Bachelor of Applied Science degree can offer an alternative pathway to certification for individuals with earned Associate and Associate of Applied Science Degrees. School districts in Yakima County employ a significant number of these individuals as classified staff members, often assisting in the classroom. Many of these individuals indicate an interest in advancing into the ranks of certified teachers, and a desire to teach in their local communities. Therefore, the college administration has initiated the necessary work to plan a program leading to the Bachelor of Applied Science in Teacher Education. The planning includes the development of the curriculum, identification of the required services and other resources to support the program, application for approval by the SBCTC (approved on May 11, 2017) and the Professional Educator Standards Board (PESB), approved on May 18, 2017. In order that the students of this program would enjoy access to federal and state financial aid, with the approval of the board, YVC intends to request approval from the NWCCU.

MOTION 17-06-01: Trustee Mendoza moved that the Board of Trustees adopt a motion to grant authority to the college to offer the Bachelor of Applied Science Degree in Teacher Education and to proceed with application for additional approvals as required. Trustee Ozuna seconded the motion. Trustee Ozuna inquired if the BAS would take an additional two years from the AA. Vice President Ybarra explained that each student's circumstances will be different and it could take up to three years. Chair Whitefoot inquired if most of the classes were going to be offered as evening classes. Mr. Ybarra indicated that the classes would be mostly evening, weekend or hybrid classes to accommodate working student's schedules. Mr. Ybarra explained that during the upcoming year preparations would be made to welcome the first class in Fall of 2018. There was no further discussion and the motion passed unanimously.

2) Approval of 2017-2018 Student Services Activities Fee (S&A) Budget.

Ms. Caitlin Goodwill stated that the college president appointed an S&A Fee Budget Committee as outlined in the YVC Financial Code for Associated Students. The members met during spring quarter. The budget office provided the S&A budget projection using a 2017-18 projected distribution less a 10 percent estimation factor. The total allocation of \$1,051,671, with an additional provision of \$25,000 for championship travel from the reserve if needed, was approved by the administration and allocated by category by the S&A Fee Budget Committee. The proposed 2017-2018 S&A budget recommended by the S&A Fee Budget Committee was presented at the May meeting Study Session. The college administration concurs with the committee's recommendation.

MOTION 17-06-02: Trustee Baldoz moved that the Board of Trustees adopt a motion to approve the proposed 2017-2018 Services and Activities Fee budget as presented in the May Study Session. Trustee Ozuna seconded the motion and it passed unanimously.

3) Approval of the 2017-2018 SRC Budget.

Mr. Brady Mugleston stated that The proposed 2017-2018 SRC budget was presented at the May study session. The proposed budget remains the same as presented.

MOTION 17-06-03: Trustee Ozuna moved that the Board adopt a motion to approve the proposed 2017-18 SRC budget as presented during the May study session. Trustee Baldoz seconded the motion and it passed unanimously.

4) Operating Budget Spending Authority.

Dr. Teresa Rich stated that the 2017-2018 State of Washington operating budget has not been approved by the state legislature or signed into law by Washington Governor Jay Inslee. Therefore, the college has not had access to final budget planning numbers. Further, the college does not have the authority to spend without expressed permission from the YVC Board of Trustees after June 30, 2017. Therefore, to continue the daily operations of YVC, the administration request Board authority to spend at the 2017-2018 proposed operating budget level of \$30,372,161, until there is actual budget data to present for approval by the Board of Trustees.

MOTION 17-06-04: Trustee Mendoza moved that the Board of Trustees adopt a motion to approve spending at the proposed 2017-2018 level of \$30,372,161 until the actual 2017-2018 operating budget can be presented and approved by the Board of Trustees. Trustee Baldoz seconded the motion and it passed unanimously.
